The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### COUNTI

Charge: INTERFERE W/ PRIVACY AT HOTEL, TAN BOOTH, OR OTHER PLACE - GAZE, STARE OR PEEP IN WINDOW OR APERTURE

Charge Description: ... surreptitiously gaze, stare, or peep in the window or other aperture of a sleeping room in a hotel, as defined in section 327.70, subdivision 3, a tanning booth, or other place where a reasonable person would have an expectation of privacy and has exposed or is likely to expose their intimate parts, as defined in section 609.341, subdivision 5, or the clothing covering the immediate area of the intimate parts; and did so with the intent to intrude upon or interfere with the privacy of the occupant;

#### STATEMENT OF PROBABLE CAUSE

On 10/14/2021, A.D.C. and A.R.B. reported to the University of Minnesota (UMPD) that the night before, 10/13/21 at around 8:50 pm, theywere using the 3rd floor women's restroom in Frontier Hall Dormitory, which is located on the University of Minnesota Campus, Minneapolis, Hennepin County, when A.D.C. saw a male attempting to peer under the shower that A.R.B.was using. She asked the male what he was doing in the women's restroom and who he was. The male didn't say anything in response and ran out of the restroom to the southwest stair well. The suspect was described as a black male, wearing a black baseball hat backwards, a black shirt with neon green letters on it, saggy black pants with red underwear showing. A.D.C. estimated his age to be in his 20's. Subsequently, UMPD investigators identified a suspect as the above-named defendant, Dontre Mason, dob 1/15/97, based on rental car records. Using surveilance video, investigators were able to track the defendant's movements from where he parks on University Ave SE just east of 13th Ave SE. The defendant is followed as he walks, and drives, through campus, including campus dormitories, until 9:08 pm. This includes a timeframe from 8:28 pm hours until 9:02 pm where he was in Frontier Hall. A.D.C. confirmed that the clothing matched that of the person she saw in the women's bathroom.

#### SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
